## Summons: Notice about Petition for Parenting Plan, Residential Schedule and/or Child Support

**To the Respondent:** The Petitioner started a case asking for a parenting and/or support order for the children listed above. You <u>must</u> respond in writing for the court to consider your side.

**Deadline!** Your Response must be served on the Petitioner within **20 days** of the date you were served this *Summons* (60 days if you were served outside of the Kalispel Indian Reservation or Washington State). If the case has been filed, you must also file your Response by the same deadline. If you do not serve and file your Response or a Notice of Appearance by the deadline:

- No one has to notify you about other hearings in this case, and
- The court may approve the Petitioner's requests without hearing your side (called a *default judgment*).

Follow these steps:

- **1. Read** the *Petition* and any other documents you receive with this *Summons*. These documents explain what the Petitioner is asking for.
- **2. Fill out** the Response to Petition for Parenting Plan, Residential Schedule and/or Child Support. You can get the Response and other forms at:

- **3. Serve** (give) a copy of your *Response* to the Petitioner at the address below and to any other Respondents. You may use certified mail with return receipt requested. For more information on how to serve, read Kalispel Law and Order Code, Chapter 3.
- 4. File your original *Response* with the court clerk at this address:

If there is no "Case No." listed on page 1, this case may not have been filed and you will not be able to file a *Response*. Contact the Court Clerk to find out.

If the case was **not** filed, you must still serve your *Response*, and you may demand that the Petitioner file this case with the court. Your demand must be in writing and must be served on the Petitioner or his/her lawyer (whoever signed this *Summons*). If the Petitioner does not file papers for this case within 14 days of being served with your demand, this service on you of the *Summons* and *Petition* will not be valid. If the Petitioner does file, then you must file your original *Response* with the court clerk at the address above.

**5.** Lawyer not required: It's a good idea to talk to a lawyer and we recommend that you do so if you have any questions, however you may file and serve your *Response* without one.
