Once the paperwork is complete, all paperwork must be filed with Kalispel Tribal Court, located at 22 Camas Flat Rd, Cusick WA 99119 between the hours of 7:00 AM-4:00 PM Monday through Thursday, excluding holidays. If your case has been previously filed with the court, documents may be emailed to court staff are unable to provide legal advice or assist with completing forms.

The filing fee for filing a Civil Complaint is \$100.00. If you cannot afford the filing fee, complete the documents included in this packet to request a reduction or waiver of filing fees.

Civil Summons

Complete the heading portion only (Name of Petitioner and Respondent) and file with the Civil Complaint.

Civil Judgment

Complete the heading portion only (Name of Petitioner and Respondent) and file with the Civil Complaint.

Proof of Service

File the completed document with the Court after Respondent is Served.
